Coverage

This occupational award covers employers throughout Australia in the health industry and their employees listed in Schedule B- Classification Structure and Definitions of the award; and employers who employ a nurse/midwife, principally engaged in nursing/midwifery duties comprehended by the classifications listed in Schedule B- Classification Structure and Definitions of the Award.

For the purpose of this provision **health industry** means employers in the business and/or activity of providing health and medical services and who employ nurses and persons who directly assist nurses in the provision of nursing care and nursing services.

To avoid doubt, this award does not cover employers who employ nurses in primary or secondary schools.

Where an employer is covered by more than one award, an employee of that employer is covered by the award classification which is most appropriate to the work performed by the employee and to the environment in which the employee normally performs the work.

In this connection the number of beds in a facility will be a relevant consideration.</p> <p>In addition to the duties of an RN4, an employee at this level will perform the following duties:</p> <ul style="list-style-type: none"> i. being accountable for the standards of nursing care for the health unit and for coordination of the nursing service of the health unit; ii. participating as a member of the executive of the health unit, being accountable to the executive for the development and evaluation of nursing policy, and generally contributing to the development of health unit policy; iii. providing leadership, direction and management of the nursing division of the health unit in accordance with policies, philosophies, objectives and goals established through consultation with staff and in accordance with the directions of the Board of Directors of the health unit; iv. providing leadership and role modelling, in collaboration with others, particularly in the areas of staff selection, promotion of participative decision making and decentralisation of nursing management and generally advocating for the interests of nursing to the executive team of the health unit; v. managing the budget of the nursing division of the health unit; vi. ensuring that nursing services meeting changing needs of clients or patients through proper strategic planning; and vii. complying, and ensuring the compliance of others, with the code of ethics and legal requirements of the nursing profession.

<p>Occupational Health Nurses</p>	<p>The duties and responsibilities of Occupational health nurses include, but are not necessarily confined to:</p> <ul style="list-style-type: none"> i. the maintenance of appropriate records relating to the activities of the occupational health unit and services to clients; ii. the rehabilitation of injured workers;

	<ul style="list-style-type: none"> iii. preventative action in relation to occupational hazards that may lead to injury and/or illness; iv. immediate and continuing treatment of occupational injuries and/or illness; v. health promotion; and vi. the counselling of clients on health related matters.
Occupational health nurse- level 1	<p>An employee at this level:</p> <ul style="list-style-type: none"> i. is an RN with at least four years post registration experience; and ii. performs duties in relation to occupational health consistent with: <ul style="list-style-type: none"> a) giving direct nursing care to a group of clients; b) assessing nursing care needs of clients; and c) participating in provision of education to clients.
Occupational health clinical nurse- level 2	<p>An employee at this level:</p> <ul style="list-style-type: none"> i. is an RN with at least four years post registration experience; and ii. performs duties in connection with occupational health which are more complex than the duties performed by an Occupational health nurse level 1. <p>Appointment to level 2 of this salary structure is only upon successful completion of a relevant post-registration qualification to this field of employment.</p> <p>Payment at this level will commence when the employer receives reasonable proof from the employee that the qualification has been obtained. The onus of proof rests with the employee.</p> <p>The duties of an employee at this level may include, but are not necessarily confined to:</p> <ul style="list-style-type: none"> i. the prevention of injury/illness; ii. rehabilitation; and iii. occupational hazard identification.
Senior occupational health clinical nurse	<p>An employee at this level is an RN with at least five years post registration experience who:</p> <ul style="list-style-type: none"> i. coordinates the occupational health nursing service; and ii. provides support and direction to four or less Occupational health nurses and/or Occupational health clinical nurses.
Occupational health nurse consultant- level 3	<p>An employee at this level is an RN with at least five years post registration experience who:</p> <ul style="list-style-type: none"> i. coordinates the Occupational health nursing services; and ii. provides support and direction to five or more Occupational nurses and/or Occupational health clinical nurses.

<p>Nurse Practitioner</p>	<p>A Nurse practitioner:</p> <ul style="list-style-type: none"> i. is a registered nurse/midwife appointed to the role; ii. has obtained an additional qualification relevant to the Nursing and Midwifery Board of Australia or its successor to enable them to become licensed Nurse practitioners. <p>A Nurse practitioner is authorised to function autonomously and collaboratively in an advanced and extended clinical role.</p> <p>Role of a licensed Nurse practitioner</p> <p>The nurse practitioner is able to assess and manage the care of clients/residents using nursing knowledge and skills. It is dynamic practice that incorporates application of high level knowledge and skills, beyond that required of a registered nurse /midwife in extended practice across stable, unpredictable and complex situations.</p> <p>The nurse practitioner role is grounded in the nursing profession’s values, knowledge, theories and practice and provides innovative and flexible health care delivery that complements other health care providers.</p> <p>Scope of practice</p> <p>The scope of practice of the Nurse practitioner is determined by the context in which:</p> <ul style="list-style-type: none"> i. the nurse practitioner is authorised to practice. The nurse practitioner therefore remains accountable for the practice for which they directed; and ii. the professional efficacy whereby practice is structured in a nursing model and enhanced by autonomy and accountability. <p>The Nurse practitioner is authorised to directly refer clients/residents to other health professionals, prescribe medications and order diagnostic investigations including pathology and plain screen x-rays.</p> <p>Nurse practitioners exhibit clinical leadership that influences and progresses clinical care, policy and collaboration through all levels of health service.</p>
